

Forward Together Reconciling Sunday School Class

On Thursday September 18th, Forward Together Reconciling Sunday School Class asked the Church Council permission to conduct a straw poll of the congregation, to determine support for Bethany UMC, Durham to affiliate with the Reconciling Ministries Network and make a commitment to work toward achieving LGBTQIA+ justice and full inclusion in the life and leadership of Bethany UMC, both in policy and in practice.

Below is the proposal presented to the council:

Forward Together Reconciling Sunday School Class

Reconciliation Proposal / Motion

Bethany United Methodist Church

In January 2018, Bethany UMC's pastor, Julia Webb-Bowden, presented an eight-week study - The 2016 "Study of the Council of Bishops Commission on a Way Forward". Approximately 23 Bethany members participated.

After the completion of the eight-week study, a smaller spin-off group decided to continue working toward Bethany being a more inclusive church. After several meetings the group went through the 5 step process and unanimously voted to affiliate with The Reconciling Ministries Network, and Forward Together Reconciling Group was born.

Forward Together Reconciling Group participated in the 2018 and 2019 Durham Pride Parades, then COVID struck, and the group went dormant. After COVID and Bethany opened up for regular churches services again, a handful of the original Forward Together Reconciling Group decided to become more active within Bethany to be a more affirming, accepting and inclusive church, and with permission from the Bethany Church Council, on June 2023, the Forward Together Reconciling Sunday Class was born. Since then, they have completed book studies, video series, and became involved in outside mission opportunities, demonstrating the dignity, love, acceptance and affirmation afforded to any beloved child of God.

After hosting a joint video series with the Lizzie Grey Sunday School Class "Faithful and Inclusive — The Bible,

Sexuality and the United Methodist Church" by Rev Rob Fuquay, Forward Together Reconciling Sunday School Class discussed their desire to petition the Bethany UMC Church Council to provide a Bethany church wide vote to affiliate with The Reconciling Ministries Network and become a Reconciling Church and expand the simple sense of welcome and belonging of ALL people into the Bethany United Methodist family.

The Reconciling Ministries Network saw success at last year's General Conference of the United Methodist Church after decades of passionate advocacy for LGBTQIA+ United Methodists. After decades of heartbreaking votes, supporters of LGBTQIA+ inclusion in the United Methodist Church family, finally achieved their goals at the 2020/2024 General Conference of the United Methodist Church. With the advocates' persistent organizing and prayers, the international lawmaking assembly voted, in most cases overwhelmingly, to remove all language condemning homosexuality from the United Methodist Church's Book of Discipline. Actions included eliminating denomination wide ban on gay clergy and same sex marriage as well as erasing an anti-gay stance that dated back more than 50 years. General Conference's decisions serve as validation of the hard advocacy work Reconciling Ministries Network has done in the United Methodist Church.

Forward Together Reconciling Sunday School Class along with the Reconciling Ministries Network believe; as the spiritual children of John Wesley, that our relationship with God is ever growing and changing with the passage of time, informed by scripture, grounded in tradition, confirmed by reason, and validated through experiences. We are all called by God to work with evangelistic zeal through the power of the Holy Spirit to encourage every local congregation to embrace and affirm the presence, participation, gifts, service and witness of the LGBTQIA+ persons within their community and that God works through folks, that churches have tried to tell us God doesn't want. When you see that work in action, we think that's really affirming and gives and renews a sense of belonging and purpose. As people of faith, United Methodists have a responsibility to lead in ways that foster healthy interaction and build communities where ALL people feel safe.

Our goal is not to be welcomed, as long as we conform, but to create a loving, affirming, reconciling community that makes a safe space for a wide array of diversity, expressions and beliefs centered around only one common goal - following Jesus' example of radical love and radical inclusion. To follow Jesus is to refuse to be conformed to this world, as the apostle Paul wrote, "but to be transformed by the renewing of your mind." (Romans 12:2) For us, this is the most faithful path that reflects Jesus' own example.

Jesus broke many legalistic traditions, to love. Forward Together Reconciling Sunday School Class along with the Reconciling Ministries Network believe that every person is called to use all their spiritual gifts and grace in the community of faith called the Church.

So, Jesus, be our voice. Be the only words we should ever speak. May our words and actions and reactions be a sanctuary for ALL.

Today, Forward Together Reconciling Sunday School Class urges the Bethany UMC Church Council to reclaim the way of Jesus — with love and compassion to welcome ALL with the light of the Holy Spirit, the care of community and the affirmation made flesh in Jesus and his kingdom, by approving this motion, to approve a straw poll be presented to the Bethany congregation to measure interest in affiliation. Based on the results from that straw poll, approve a congregational vote to affiliate with the Reconciling Ministries Network and become a beacon of love, hope, acceptance, affirmation and celebration, of ALL religious and nonreligious in our area.

Forward Together Reconciling Sunday School Class



Dear Bethany Church Family,

It is that time of the year where things are beginning to cool off and the school year is finally getting into full swing. The leaves are beginning to change in color. The breeze is feeling more crisp. New rhythms are falling into place and we are beginning a new season. Just as all these things are happening there is something special happening in the Bethany Church community. It is time for THE Brunswick Stew cook.

I remember arriving at Bethany last year and the time was coming close for the Stew cook and people kept mentioning that Stew was coming up. Stew was an event that everyone knew and was brought up often so I had to ask, "Is this a big thing at Bethany?" And there was a resounding, "yes," every time I asked. There was and is an energy, a camaraderie, a unity, a community, a tradition, a memory making, a fellowship that surrounded and

surrounds the Bethany Brunswick Stew.

Honestly, I felt a little on the outside when asking about this famous Stew. Everyone knew about it and had a claim on it. It was something I couldn't fully understand as I had never been a part of such a large process in the church or any community. My previous churches had never endeavored to cook such a large amount of food with everyone for a fundraiser. We had fundraisers but nothing that required volunteers rotating to help with over 24 hours of consecutive work. It is amazing to think how everyone comes together to create this delicious meal that will feed hundreds and hundreds of people.

It sounds like that story where Jesus has compassion on a crowd following him and he tells his 12 disciples that they need to feed 5,000 people with 5 loaves of bread and 2 fish. Yes, multiplying fishes and loaves is a miracle but so is 12 people serving meals to 5,000 people. The Bethany Stew feels a lot like taking a small amount of people and feeding a large number of people. The task seems impossible when you talk about the process of creating over 1,000 quarts of brunswick stew for the community. The amount of ingredients, spices, meats, and vegetables required for such a cook is immense but also what is required to process all these things are dozens of people to clean, prepare, chop, cook, process, store and deliver this brunswick stew. It is a miracle that such a thing could take place at a church that averages around 50 or so people on a Sunday morning. That is amazing and something that I know we are proud of.

Last year I got to help with cleaning and chopping up vegetables. I also got to help stir the stew for a while before leaving to see some family. It was special. Like I said above, I had never experienced anything like it in my life. This wasn't like working in a restaurant to prepare for a dinner service. That's a job, this was community. This was a bunch of normal, everyday church people coming together in love to make food that would help support the church & its ministries and also fill the bellies of families. This stew is the provision of manna for people in their own wilderness of life. This stew is for the parent who needs an easy dinner to heat up for their family. This stew is for the sick person who can just throw it on the stove when they need it. This stew is for bringing people around the table. This stew is not just food, it represents tradition, gathering together, working hard, conversation with others, stepping outside of ourselves, becoming a part of something bigger than ourselves, humility, service, remembering those who have gone before us, and sharing life with one another.

I kind of get it after doing it once and I hope that we continue to invite others into that process in a humble and inclusive way because we do have something special that is worth sharing with others. I'll see you on October 3rd as we "stew" together.



September 18, 2025

Opening Prayer

Pastor Cole opened the meeting with a word of prayer.

Minutes

June's council meeting minutes were approved via email.

August 13 zoom meeting:

The meeting was held to discuss what could and should be done regarding unhoused persons using the stew hut shelter. Pastor Cole had contacted nearby churches and organizations that have experience with similar situations. No trespassing signs were already up at the stew hut and a document had been signed allowing police to ask people to leave, but neither had helped.

Cole made a motion for 2-3 people to speak with the unhoused persons staying in the stew hut to let them know that our leadership met and decided that we cannot allow them to stay on the property. The tent and people need to vacate within a certain amount of time (by August 21) or we'll need to call the police. Seconded (didn't catch by who). The vote passed with no one opposed. Cole, Dan (and Bailey), and Lynne planned to do this on Friday (8/15) at 9:30am. Cole also updated the congregation the following Sunday.

Spiritual and Leadership Formation- led by Pastor Cole

We reviewed our Mission Statement, Vision, Core Values, and Meeting Norms.

Moving forward, we will better follow Robert's Rules and use a microphone during council meetings. Everyone will be able to ask a question, give a speech for, or give a speech against a motion. We will also include content warnings before discussions about potentially triggering subjects.

Galatians 5:13-26

In this space of leadership we are in danger of acts of the flesh (desires to do harm), like fits of rage, selfish ambition, factions, discord, and dissentions.

In this space of leadership we can embody fruits of the spirit through love, self-control, kindness (responding not reacting), gentleness, faithfulness, respect, joy, and peace.

People recognize us by how we love one another.

Pastor Cole concluded this reflection period with prayer.

Review of New People- led by April

Hannah (a divinity student) has been back several times, including at Led by Love!

Goal and Visioning Work

What have we done or worked on already:

We revisited the Table at Bethany grant for an emerging ministry by using it for Led by Love/ The Group.

We created a new small group ministry (Led by Love).

We began dialogue about the Fellowship Center.

We started getting to know our neighbors better through the Pancake Breakfast and its added offerings of showers and the clothing closet, also facilitated by Forward Together on additional days (Showers of Blessings). We've also continued working with the nearby preschool, which held their graduation in the Fellowship Center, by sharing start of school bags.

We partnered with Durham Cares by participating in Journey to Thriving and have a Pilgrimage scheduled Nov 7-9 to continue learning about our community and go out into it.

Our website has been kept up with and the communications team is investigating streaming on YouTube.

Led by Love held an event in a neutral space by feeding community members near Jubilee House.

We are planning our yearly Trunk or Treat, which provides a connection with local families to Bethany.

Things to work on for the rest of the year:

We want to plan a second event to connect with local families, likely after Halloween. Ideas include inviting families to the Cantata, a storytime or movie night (The Chosen), and going caroling with cocoa.

Leadership Council Packet Items (reports not discussed during the meeting are included at the end)

Questions from emailed reports

Is there still no trash can at bus stop and do we know why it was removed?

We've received no answer as to why it was removed and we are seeing an increase in litter. Gerhard will reach out again to follow up (and request a trash can, if possible).

In the Trustees report for September there was a recommendation to revise the usage agreement for Roca Eterna.

This recommendation needs more work and will be tabled until the October meeting.

Hector from Roca Eterna needs contact info for someone at Bethany, as Gary CO has been approached several times when he has concerns.

A Finance clarification from Lynne: The salary increases in the SPRC report were used to create the budget, but are not approved by Finance. The Leadership Council will vote on whether to approve them when we vote on the budget.

Reconciliation Proposal / Motion – presented by Michael CO on behalf of the Forward Together Reconciling Sunday School Class

Michael CO made a **motion** to allow Forward Together Reconciling Sunday School Class to take a congregational straw poll to see if the congregation is interesting in moving towards becoming a reconciling ministries congregation. Gary CO seconded the motion.

Discussion/ questions:

How does that change what we're doing now?

It makes what we are already doing official outwardly, increasing visibility and making a public statement.

What other Durham churches are reconciling congregations?

Elizabeth St UMC (first in NC), Epworth UMC, Citywell, Parkwood UMC

How is a straw poll done?

It is a ballot vote with the choices to approve or need more info. It is anonymous and includes a place to write questions. It is done with those present and will be advertised beforehand. We can have a series of information in mid-week emails and a presentation at the service where the vote takes place to provide information.

What does becoming a reconciling church mean to Bethany?

It will increase advertising to LGBTQ+ individuals that we accept and support them and are a safe place. It also provides a public statement of that acceptance and support.

How is it different from Lighthouse?

A Lighthouse congregation is advertised as a place for people to go whose church disaffiliated if they did not want to disaffiliate.

What do we have to do differently as a reconciling church?

The reconciling statement has to be on everything (i.e. website, bulletin, newsletter).

Vote- passed, none opposed

Naloxone (Narcan) Container recommendation- report provided by Gary Crispell

On October 17, 2024, the Leadership Council met and approved that, "a Naloxone vending machine be allowed to be placed on BUMC" with the understanding that we approve of an appropriate location for the machine.

This Naloxone machine is provided by the Durham County Department of Public Health, specifically their Harm Reduction Team. They will make sure the Naloxone machines are kept stocked for those who might need it.

On August 28, 2025, Pastor Cole, Gary Crispell, Pete Crispell and Gary Corsi-O'Connor met with Morgan Culver who is the head of the Harm Reduction team. We walked around campus and she saw a few spots that might be good spots for a Naloxone box to be set up. Here were her suggestions on best places for the box:

Next to the Little Free Pantry.

Next to the Bus Stop bench (as long the box is not prone to fall over and can be stabilized).

At the front of the Fellowship Center building against the building.

We are asking for feedback from the Leadership Council on which location to place the Naloxone box. Thank you for your help in this matter.

The same people who use the Little Free Pantry would likely use the naloxone (it saves lives). Peter would pour a concrete pad to secure both, and it could face a different direction from the pantry.

Gary C made a motion to locate the naloxone dispenser next to the Little Free Pantry. Gary CO seconded.

Discussion:

The Narcan that we've had goes very quickly, and is taken away, not used there. People are looking for it in that area, and this is an opportunity to supply greater amounts.

What size is the box?

It is newspaper dispenser size (same as the pantry). We don't know yet what it looks like.

Who stocks it?

Durham Health Department will stock it

Vote- Passed with none opposed

Trail Camera Usage- presented by John Roberts

John Roberts made a **motion** to install trail cameras (4) around the rear of the education building and the stew hut shelter to see if there are fires or other unwanted activity occurring there overnight. Sharon seconded.

Discussion

Will we disclose to the congregation that there are cameras?

Yes, we will announce it on Sunday.

Have they been used elsewhere on campus before?

No. Lisa bought them but they haven't been used.

All info is after the fact- can we monitor in real time?

No, there's no wifi capability.

One future possibility is getting a Ring camera for \$30/ year if we see a need with these.

They can be helpful for other things too, like seeing what's going on when nearby robberies happen.

Vote- Passed, none opposed

FINANCE - 2026 Budget report provided by Lynne Sprague

On July 8, 2025, a team under the direction of Finance conducted a review of Bethany's Finances for the year 2024. This review used the guidelines from the Book of Discipline as well as the Internal Controls and Procedures for Bethany UMC. The report was emailed to Leadership Council members on July 28, 2025, to be approved via email. Following approval the report was submitted to NCCUMC.

A copy of this report is provided (below, with additional reports).

On August 21, 2025, Finance Committee met. Lynne opened the meeting with scripture and prayer. Pastor Cole and Cathy shared the on line data system Cathy is using for financial records. The next item on the agenda was to set a budget for 2026. The committee took into account requests submitted by those in charge of line items in the budget. We also had to consider the information received from NCCUMC regarding apportionments and pastor's compensation. Adjustments were made to salaries to align with recommendations from SPRC.

In some cases line items were reduced as other income was available through a designated fund. Finally some line items were increased because of rising costs. The committee is aware that many of our folks are also facing rising costs, and we wanted to send a message that we struggled with this budget, and that we really tried to keep increases to a minimum.

Along with our budget discussion, we also had a tough discussion regarding our building fund. Monies are sufficient to make 2 maybe 3 loan payments and then what? We already know that the October fellowship dinner is designated for the building Fund, and we also know that a portion of the stew proceeds will help. We need more ideas!

A copy of the proposed budget is attached.

Important points and discussion:

We know money is tight for everyone, so it's hard to keep asking for more

There was a 1.6% total increase in the budget from last year, including 3% pay increases for the pastor and handbell director and a 2% increase for the minister of music.

One reason for pay increases is that finding subs for the pastor and musicians at the previous pricing is difficult.

There is a designated fund (\$1,614) for music maintenance that we can use, if needed.

The large increase in apportionments was discussed. This is the first full year out of affiliation so they lost churches paying into it. To be fair they did a 2.5% adjustment to apportionments (would have been more without adjustment). It also re-

mained higher as they didn't want to cut funds for the Methodist Home for Children. It was figured based on individual churches.

Building Fund- there is not enough in it for the next two months. We predict that we'll get enough from stew, football games, etc. for now, but we need to dispose of the Omah St property to give us money to work with (our debt takes about 19% of our income for the year). We need additional means of income. The Oct Fellowship dinner will go towards building fund with a \$1000 match.

Bethany United Methodist Church Committee on Nominations & Leadership Development 2025 Charge Conference Report

This year (2025) the NC Conference of the United Methodist Church is requiring churches using an alternate leadership structure to report this model and how it functions. In 2019, Bethany UMC switched to a One Board Model. This was adopted into practice but due to the 2020 COVID-19 Pandemic a hybrid of this model was held moving forward. Today we continue to live into a hybrid of the traditional Book of Discipline model and the One Board Model. With this upcoming Charge Conference and the new requirement of reporting Alternate Leadership Structure by the NC Conference, we, the Committee on Nominations & Leadership Development, propose that we move forward with fully living into a Simplified-Accountable Leadership Structure (formerly called a One Board Model). Below are the nominations for what that structure might look like for our context here at Bethany United Methodist Church.

The NC Conference offered three options for Alternate Leadership Structures to be lived out in local churches. Copies of this information with the different leadership structure options provided by the NC Conference were emailed out to the entire Leadership Council and the Committee on Nominations & Leadership Development on July 31, 2025 by Pastor Cole. We decided that Option 2 (A Leadership Council with More Than 9 Members) was most suitable for our congregation based on our current structure, church needs and congregation's size. Below is what our Leadership Structure might look like under this option.

Essentially what a Simplified, Accountable Leadership Structure would do is combine the duties of the UM administrative committees (SPRC, Finance, Trustees) into one Leadership Council. Instead of having several different committees meet throughout the month in silos, this structure would allow conversation on issues to happen with all the different church leaders at the same time. In the traditional model, issues may have to be brought to several committees before being approved (or even disapproved) by the Church Council but this simplified structure allows for quicker communications, critiques and approvals of certain ideas because all of your different administrative leaders are gathered around one table.

The proposed Leadership Council for 2026 will take on the responsibilities of the Trustees and Finance. The Book of Discipline limits the amount of Trustees to 9 people so we decided to name specific members of the Leadership Council as Trustees (only these 9 can vote on Trustees items but everyone can participate in the discussion of such matters). The 9 Trustees are: Leadership Council Chair, Lay Leader, SPRC Chair, Finance Chair, Finance Secretary, Church Treasurer, Trustee Chair, Recording Secretary and the Pastor.

In consultation with our Trustees Chair, Gerhard Mels, we put together a Building Maintenance Team to handle the day to day upkeep of the church property (see the nominations listed below). This team will handle small repairs, upkeep and care of the property so as to not bog down the Trustees who will focus on more big picture issues such as insurance, mortgages/banking, legal concerns, etc. This team will be under the Trustees Chair's responsibility and they will communicate closely with the Trustees Chair about concerns. Gerhard has scheduled a meeting with this team to iron out processes for how the relationship between the Trustees, Trustees Chair and Building Maintenance Team will look moving forward.

In our discussions we decided to keep the SPRC as a separate entity from the Leadership Council for a few reasons. First, keeping the SPRC separate from the Leadership Council will give less power to the Leadership Council as we transition into this new model. We do not want this transition to result in abuse of power and so this is a measure of good-faith to the congregation as we seek to gradually adopt a Simplified, Accountable Leadership Structure. Second, SPRC will become a great place to introduce new members to administrative duties without the pressures associated with the Leadership Council. It will be a great place to get different people involved in the administration of the church. Third, SPRC meetings deal with confidential matters that are to be discussed in private. Having a smaller SPRC would foster greater adherence to confidentiality. Fourth, the SPRC can only have a maximum of 9 members according to the Book of Discipline. Since we are proposing a Leadership Council with more than 9 members, we thought it would be best to keep the SPRC separate so that it doesn't disrupt Leadership Council meetings. If the SPRC combined with the Leadership Council and an SPRC matter came forward, it would be required for non-SPRC members of the Leadership

Council to leave during that portion of the meeting. This would disrupt the flow of meetings and would likely make individuals, both on and off the Leadership Council, feel excluded.

AUDIT REPORT 2024-BETHANY UMC

An independent committee of the church completed an audit of the financial reports and records and reviewed the internal controls of Bethany UMC. The church is following its adopted Financial Controls, Policies, and Procedures which were revised in 2021. The treasurer is approved to write routine checks on behalf of the church and that list was updated.

Financial reporting is reliable and records are safe. The above stated policies along with The Local Church Audit Guide provided by the UMC were used in performing this review. It is our opinion that the records and reporting for 2024 fairly represent the financial condition of Bethany UMC.

Receipts and Disbursements

Cash receipts for the year were reconciled with monthly bank statement and GL#0001, and this included \$193.73 in electronic donations. Twelve deposits were traced to the cash receipts journal for posting accuracy and then to the bank statements. Weekly count sheets for these same deposits were checked for proper signatures. The source of income received on the count sheets was traced to the cash receipts journal and to the General Ledger. No concerns were noted for accu-

racy, but it was suggested that there be a weekly count sheet accompanying the electronic donation.

Of the 312 checks written, a random sampling of 33 checks was selected to review. Invoices were checked for payment accuracy and approval by 2 members of the finance team. The checks were traced through the cash disbursement journal to the General Ledger. Then they were verified by the bank statement and no irregularities were noted.

Reporting and review

The Operational Account and the Money Market Account at Truist Bank were reviewed for reporting accuracy to the General Ledger.

Beginning cash balance for Operational Account – GL#0001 – for Jan. 1, 2024 (\$124,074.17) was verified to the bank. Total receipts (\$299,152.22) and total disbursements (\$316,991.31) for the year were verified from bank to General Ledger. Bank statement for Dec. 31, 2024 was reconciled to the General Ledger to ensure that cash balance (\$106,235.08) at year's end was accurate.

The end of year statement prepared by the treasurer and dated Dec. 31, 2024, was reviewed and all balances were traced to the General Ledger for accuracy and agreed with the end of year report.

Finally, the Church Council Minutes were reviewed to ensure that financial activity over and above the budget was being brought to council for approval. The minutes should accurately reflect financial impact for special projects and unexpected costs through motions, approvals, and acknowledgements that such funds were used as approved. On Nov. 21, Gary Crispell on behalf of the property committee asked that the Council approve \$1,500.00 from stew fund to pay Howard Stallings Law firm. The Leadership Council approved this request. The General Ledger Accounts show the transfer from stew fund to Legal fees and legal fees were paid; however, acknowledgement to the minutes was not found.

Tax Reporting RequirementsIndividual employee wage records, employer's quarterly tax returns (Form 941), NC withholding (if applicable) and employee W-2 records were reviewed. A checklist of the above reports was completed in order to show accuracy of the reports submitted on behalf of Bethany UMC. Wage information was traced to the General Ledger and reports were filed on time.

BUMC Building Fund

The beginning balance for the building fund for 2024 was \$20,612.29. Monthly contributions including offerings, memorial gifts, stew fund, and other special gifts, etc. totaling \$51,311.67 were compared to the general ledger for accuracy. The loan payments for the year totaled \$55,059.96. Balance brought forward plus yearly gifts minus the payments left a balance to GL#1001 of \$16,864.00. This agreed with year end report for 2024.

Holsclaw Endowment Distribution

The endowment for 2024 was \$2,310.88. The list of local missions agreed with the leadership council minutes and the distributions indicated were correct and traced to the treasurer's report.

Other – general comments

The committee reviewed the most recent property insurance documents and acknowledged that a list of church property for insurance purposes should be available, including item description, serial number, and value. Such description and value is on file for handbells.
